**REASONS FOR REQUEST OF  
ELECTRONIC SURVEILLANCE AUTHORIZATION**

Authority for electronic surveillance of Bayard Rustin, Apartment 2J, 340 West 28th Street, New York, New York, was obtained on October 31, 1968. This surveillance was requested in order to develop information regarding the plans of the Communist Party, USA (CPUSA), relating to influences in racial matters. On June 4, 1968, and November 26, 1968, the Attorney General was advised that the surveillance would be continued for an additional six months unless he instructed to the contrary.

**SECURITY PURPOSES INTENDED TO BE SERVED BY  
SURVEILLANCE WHEN INSTITUTED AND PERIODICALLY CONTINUED**

Reliable information had been received that Benjamin J. Davis, National Secretary of the CPUSA, indicated at a meeting of the National Board, CPUSA, that he had been maintaining liaison with Bayard Rustin. Davis had also commented that the Negroes were willing to know what the Communist Party had to say and to welcome whatever support the communists could give "in this new stage, which is how to break the resistance of the Dixiecrats and how to stop the McCarran Act." This coverage provided valuable data regarding communist influences in racial matters particularly communist influences on the late Martin Luther King, Jr.

No other coverage was monitored on different surveillances on the same premises.

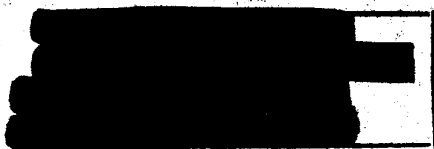

Bayard Rustin resides at Apartment 9J, 340 West 28th Street, New York, New York. Rustin, who was the Deputy Director of the August 28, 1963, March on Washington, continues to participate in the current Negro struggle for civil rights. According to a confidential source who has furnished reliable information in the past, Benjamin J. Davis, National Secretary, Communist Party, USA (CPUSA), while at a recent meeting of the National Board, CPUSA, indicated that he is maintaining liaison with Rustin. Davis also commented recently, according to this same source, that the Negroes are now willing to know what the Communist Party has to say and to welcome whatever support the communists can give "in this new stage, which is how to break the resistance of the Dixiecrats and how to stop the McCarran Act."

In order to obtain further information concerning the plans of the CPUSA relating to influence in racial matters, it is requested that authority be granted to place a technical surveillance on the residence of Bayard Rustin or on any future residence to which he moves.

A technical surveillance was instituted on the residence of Bayard Rustin, Apartment 9J, 340 West 28th Street, New York City, on November 15, 1963. Rustin is a former member of the Young Communist League, an organization which has been designated subversive pursuant to Executive Order 10450. He has for many years maintained an association with members of the Communist Party, USA. Rustin is a principal leader in the civil rights movement and is a frequent and close advisor to Martin Luther King, Jr.

This technical surveillance has provided much valuable information concerning communist influences in the civil rights movement, particularly through specific communist influences upon King. It has also provided information concerning the communist influences upon King relative to King's position concerning the Vietnam situation. Some examples will serve to illustrate.

In July, August and September, 1965, information was obtained that Rustin was preparing speeches and other material as well as counseling King in respect to the Vietnam situation. In this regard, it is noted that King has been taking a position opposed to this country's foreign policy relative to Vietnam. During August, 1965, Rustin closely counseled King relative to the position which the latter took and expressions made by King concerning the riots which had occurred in Los Angeles, California, during that month. Information was also obtained concerning the role which Rustin played as an advisor to King relative to a conference of civil rights leaders which was held in Washington, D. C., November 17-18, 1965.

Unless you instruct to the contrary, this technical surveillance will be continued for an additional six months.

On November 15, 1963, a technical surveillance, [redacted] was instituted on Bayard Rustin, 340 West 28th Street, New York City. He is a former member of the Young Communist League and has for many years maintained contact with some Communist Party, USA, leaders. He is a known sexual pervert. Rustin is a prominent Negro civil rights leader and a close advisor to Martin Luther King, Jr. The purpose of this surveillance is to determine communist influence on Rustin's activities in the civil rights movement, as well as influence exerted on King by Rustin.

This surveillance costs approximately \$254.83 per month and utilizes a leased line. It is monitored at the New York Office.

This surveillance has provided valuable information concerning Rustin's influence in the civil rights movement and the peace movement, particularly through his specific influence on King. In July, August, and September, 1965, this source furnished information that Rustin was preparing speeches and counseling King in respect to the Vietnam situation. Rustin closely counseled King relative to the position which King took concerning the riots which occurred in Los Angeles, California, in August, 1965, the source reported.

King, in the Summer of 1965, became the center of violent controversy when he indicated he planned to write letters as a peace move to the heads of all countries involved in the Vietnam situation. By memorandum dated September 16, 1965, we furnished the White House information from this source that King would not write the proposed letters, as he had previously indicated. This was the initial indication that King had backed down from his controversial plan. This source also furnished information concerning the role Rustin played in arranging for a conference of civil rights leaders to be held at the White House in November, 1965. This information was furnished the White House on August 17, 1965, far in advance of the scheduled conference.

Rustin is in close contact with Stanley Levison, Clarence Jones and Harry Wachtel, all key advisors to King who have backgrounds linking them to the communist movement. He is probably King's outstanding contact man with various Negro leaders. Evidence that Rustin still plays an important part in King's activities was furnished by the source on 1/2/66, when Rustin was contacted by Harry Wachtel to see if Rustin would go to Atlanta, Georgia, on 1/14/66 to participate in the scheduled executive meeting of the American Foundation for Non-Violence, a new tax exempt organization formed as a fund-collecting apparatus for King's Southern Christian Leadership Conference. Rustin indicated he would try to attend this meeting.

OBSERVATION:

Rustin is a very competent individual who is widely known in the civil rights field. He is personally familiar with numerous individuals with communist backgrounds. As one of Martin Luther King's closest advisors, he is in a position to wield considerable influence on King's activities. Technical coverage of Rustin is an important part of the overall coverage of King, who is the most prominent civil rights leader in the country today. Because of the influence being exerted on King by persons with subversive backgrounds, it is necessary for us to maintain coverage of individuals such as Rustin.

RECOMMENDATION:

In order to fulfill the Bureau's responsibilities to uncover communist influence in racial matters, it is recommended that technical coverage of Rustin be continued.

The following is deemed of interest to the Bureau and New York with regard to the criminal record of BAYARD RUSTIN as a homosexual, because it demonstrates that the Minutemen organization is aware of his arrest in Pasadena, California, in 1953.

The San Francisco Office is presently conducting background information on \_\_\_\_\_

\_\_\_\_\_ area, which is at the southern end of San Francisco Bay. He has been told by individuals who claim to be members of the Minutemen that members of police departments and other law enforcement agencies are members of the Minutemen. They have not yet been identified to him.

He has also been told that the Minutemen have access to police records and identification records. He suspects that this access is in the Southern California area, possibly at or near Santa Barbara. He was told that the Minutemen know that one of the leaders of the March on Washington had an arrest record as a homosexual. He has now reported that his associates in the

Source furnished information concerning a contact between RUSTIN and [redacted] (a confidante of RUSTIN's), during which time RUSTIN related to her information he had received concerning a meeting of the President and civil rights leaders on that date.

*Cont.* In addition, the source furnished information that RUSTIN was helping MARTIN LUTHER KING prepare his testimony (to present to the Platform Committee of the Democratic Party), as well as information regarding the seating of the Freedom Party delegation. (Disseminated to the Bureau, Atlanta and to New York case files in airtel and letterhead memorandum dated 8/24/64).

*Cont.* Source advised that RUSTIN and MARTIN LUTHER KING, JR., and ANDREW YOUNG (Assistant to KING), conferred concerning the Democratic National Convention, which was to open on 8/24/64, in Atlantic City, New Jersey. During their conference, RUSTIN advised KING as to what strategy he should use in regard to the Convention, as well as to when he should arrive and depart at and from the Convention. Source furnished information about RUSTIN's contact with the New York Office of the FBI, during which time he furnished information relating to the Harlem riots. During the past three months very valuable information has been obtained from this source. Some examples are: On 8/24, 25/64 information obtained concerning plans of King to testify before the Platform Committee of the Democratic National Committee and strategy King intended to use at the Democratic Party Convention. On 9/25/64 and 10/6/64 information obtained concerning a speaking engagement of King. On 10/6/64 source advised concerning the Convention of the Southern Christian Leadership Conference (SCLC) (headed by King) held 9/29-10/2/64 and the fact that Rustin wrote a section of the SCLC program. On 10/20/64 intelligence obtained concerning plans of King and other civil rights leaders to tour the country on a "get out the vote" campaign. Valuable specifics obtained. The Director has instructed that there are to be no technical surveillances in cases which would thereby be tainted for prosecution.

[Redacted] is a technical surveillance on Bayard Rustin, Apartment 9J, 340 West 28th Street, New York City. It was authorized 11/1/63 and installed 11/15/63. Rustin, a former member of the Young Communist League, is an extremely active leader in the Negro movement and was Deputy Director of the 8/28/63 March on Washington. He was formerly an employee of Martin Luther King, Jr., and in recent months has been a close advisor to King, particularly in connection with King's activities relating to the Democratic National Convention recently held in Atlantic City, New Jersey. Because of the communist influences on King and the background of Rustin, who still maintains some communist associations, we have been securing very valuable information through this source.

There is no prosecutive action pending relative to Rustin and, on the basis of the facts known concerning him, none appears indicated in the foreseeable future. It would therefore be well to continue this technical surveillance because of its large contribution to our intelligence in the most important racial movement area of our responsibilities.

RECOMMENDATION:

The technical surveillance on Bayard Rustin, [Redacted] be continued.

In light of the current civil rights strife and RUSTIN's participation therein, it is believed that the continuation of this source is necessary to permit the Bureau to continue the fulfillment of its responsibilities. Furthermore, this source has been of extreme importance in furnishing information concerning MARTIN LUTHER KING, JR., his plans and contacts. This in itself would appear to be sufficient to continue the source.

This information has included details concerning meeting between Rustin and Cleveland Robinson, Secretary-Treasurer, District 65, Retail, Wholesale and Department Store Union, AFL-CIO, wherein it was agreed to have another March on Washington on 6/15/64 to be led by Robinson and made up of ministers, rabbis and labor leaders; Rustin's conference with Martin Luther King, Jr., 7/17/64, regarding background information on King to be presented to a Swedish group considering the Nobel prize for King; Rustin's conference on 7/18/64 regarding the Mississippi situation--they discussed a meeting to be held 7/23/64 at Jackson, Mississippi, which meeting was to be attended by leaders of the various racial groups, including Martin Luther King, Jr. King conferred with Rustin on 7/26/64 seeking advice regarding the riots in the Harlem area of New York City and Rochester, New York. King also sought advice regarding his conference with New York City Mayor Wagner. This source also furnished information regarding Rustin's observations as a consequence of Mayor Wagner's refusal to appoint a civilian police review board. Rustin indicated that "we" could not request that Negroes refrain from demonstrating.

This is a justification for [redacted] a technical surveillance (tesur) on Bayard Rustin, 340 West 28th Street, Apartment 9J, New York City, based upon results obtained during the past 3 months. This tesur was authorized on 11/1/63 and installed 11/15/63. Rustin who has admitted prior communist affiliation, continues to be an influential figure in the current Negro movement.

During the past 3 months valuable information was obtained from this source, which information has been utilized in the Bureau's investigation concerning communist influence in racial matters. Examples are: On 2/19/64 this source advised that Rustin conferred with Benjamin J. Davis, Communist Party, USA (CPUSA) National Secretary. Rustin desired to know how he could get out of a speaking engagement scheduled for 2/26/64. On 2/23/64, information pertaining to a request of Rustin by the National Association for the Advancement of Colored People to direct a march on Albany, New York, 3/10/64, was received. On 2/24/64 source advised that according to Rustin he was not going to speak at a rally scheduled for 2/26/64 because sponsors of the event were "fellow travelers or communists" and he feared the possibility of adverse publicity to the civil rights movement. On 2/26/64 information pertaining to a contact between Norman Hill, Program Director of Congress of Racial Equality, (CORE), and Rustin was received. Hill advised that he was of the opinion that the CP had gotten into the Brooklyn and Bronx, New York Chapters of CORE. On 3/31/64 this source advised that Rustin dictated a document to the secretary to A. Philip Randolph (President of the Brotherhood of Sleeping Car Porters) which document was to be disseminated to various civil rights leaders, bearing Randolph's signature. On 4/8/64, information relating to a conference between Rustin and Hill concerning plans for demonstrations on the opening day of the New York World's Fair, 4/22/64, was obtained. This source advised on 4/21/64, that Rustin and Hill conferred about World Fair plans with Rustin remarking that he wanted to be arrested. In addition, Rustin stated he would lead a march on the Democratic and Republican Conventions this summer for the purpose of unseating the Mississippi delegation.

In view of the valuable intelligence data obtained from this source and the influential position held by Rustin in the Negro movement, coupled with communist influence in this movement, the continuance of this tesur for another three months is recommended.

Relet noted that Rustin departed for Europe 1-4-64 and was not to return until 1-15-64. Your feeling was expressed that the information which has been received from this source has not been of sufficient value to warrant its continuance and that it would be discontinued on 1-31-64 unless information is received prior to that time which would justify continuance of this source.

The Bureau has closely reviewed the information which has been obtained from this source since its inception 11-15-63, and has evaluated its value coupled with the important position which Rustin holds in the Negro movement today and particularly the communist influences which are brought to bear on and through him. Of particular significance is the information obtained through this source on 12-15-63 that Rustin was still maintaining liaison with Ben Davis, National Secretary, Communist Party, USA.

It is the Bureau's conclusion that, all factors considered, the continuance of [redacted] for another 20 days is justified and you are instructed, therefore, to not discontinue on 1-31-64 as you indicated you would. In view of Rustin's absence from his residence for the approximate period 1-4-64 to 1-15-64 and so that your next justification

The foregoing instruction does not preclude your corresponding with the Bureau at an earlier date relative to discontinuance of this source should you feel its continuance is definitely not further justified.

NOTE:

Rustin was Deputy Director of the 2-28-63 March on Washington and is a key figure in the Negro movement and communist influences therein. Of particular significance is his liaison with the Party through Ben Davis. In addition to the 12-16-63 contact with Davis, source also made available information concerning an attempt by Rustin to contact Paul Robeson, Jr., 12-24-63 and on 12-27-63 source advised of plans to close the March on Washington office as well as possible plans for additional demonstrations in connection with civil rights legislation. It will also be recalled that this source furnished information on 11-18-63 which contained details of Rustin's homosexual proclivities which information was not available from any other source. It was of such value that Mr. Tolson noted, and the Director concurred, "Evans might show enclosure to AG when an opportunity presents itself to show up Rustin for what he is."

When he learned that DAVIS was not there, RUSTIN left a message that he would be unable to keep his appointment with DAVIS that afternoon. On 11/16/63, information was received that BAYARD RUSTIN was writing a speech dealing with the civil rights movement, for A. PHILIP RANDOLPH, to have been given at the AFI-CIO Convention in New York. In connection with this, RUSTIN said he planned to meet with RANDOLPH, WALTER REUTHER, REUTHER's assistant, and TOM KAHN.

(The foregoing information was furnished to the Bureau by airtel and letterhead memorandum dated 11/18/63).

On 12/5/63, information was received that RUSTIN had contacted MARTIN LUTHER KING on that date in order to invite KING to speak at a conference in New York on 12/13/63, for Turn Toward Peace. KING said he would have to check his schedule and advise him later.

(The foregoing information was forwarded to the Bureau by airtel and letterhead memorandum dated 12/6/63).

In view of the fact that there has been no information from this source which would indicate that BAYARD RUSTIN has come under the influence of the Communist Party in connection with his civil rights activities, it is recommended that this informant be continued for another 30 days at which time a re-evaluation will be made.

18. Recommendation by Assistant Director:

This is the initial justification for continuation of a technical surveillance (tesur) on Bayard Rustin, 340 West 28th Street, Apartment 9J, New York City. It was authorized 11/1/63 and installed 11/15/63. Rustin, who has admitted previous Communist Party affiliation and who was a principal in the 8/28/63 March on Washington, continues to maintain a leadership position in the current Negro struggle for civil rights. As late as 9/20/63, Rustin and Benjamin J. Davis, National Secretary, Communist Party, USA, mutually agreed to a future get-together for personal discussions.

Examples of information furnished by this source are as follows: On 11/16/63 information indicating Rustin prepared A. Philip Randolph's speech for the AFL-CIO Convention in New York was received. (Randolph is President of the International Brotherhood of Sleeping Car Porters.) On 12/5/63 information was received concerning Rustin's invitation to Martin Luther King to speak at a conference in New York on 12/13/63 for Turn Toward Peace. Also on 12/5/63 information was received that Rustin was trying to raise money for the purpose of sending [redacted] to Mississippi for work with the Student Non-Violent Coordinating Committee. [redacted] according to this source, has assisted Rustin in writing speeches for King. ([redacted] was affiliated with the Young Peoples Socialist League (YPSL) as late as July, 1960. The YPSL is an affiliate of the Socialist Party-Social Democratic Federation.) Information received on 12/5/63 indicated that the March on Washington office isscheduled to be removed in the near future.

New York recommended that because this source furnished no information which would indicate Rustin has come under Party influence in connection with his civil rights activities it be continued for another 30 days (instead of the usual 90-day period) at which time a re-evaluation will be made. It is imperative that we penetrate the Party's liaison with leaders of the current Negro struggle for civil rights. Information previously received indicates that the Party feels Rustin could be receptive to its contacts. Coverage afforded by this tesur is an important part of the Bureau's over-all coverage of communist influence in racial matters. It is recommended that it be continued for an additional 30 days at which time it will be re-evaluated.

Bayard Rustin resides at Apartment 6J, 240 West 26th Street, New York, New York. Rustin, who was the Deputy Director of the August 28, 1963, March on Washington, continues to participate in the current Negro struggle for civil rights. According to a confidential source who has furnished reliable information in the past, Benjamin J. Davis, National Secretary, Communist Party, USA (CPUSA), while at a recent meeting of the National Board, CPUSA, indicated that he is maintaining liaison with Rustin. Davis also commented recently, according to this same source, that the Negroes are now willing to know what the Communist Party has to say and to welcome whatever support the communists can give "in this new stage, which is how to break the resistance of the Dixiecrats and how to stop the McCarran Act."

In order to obtain further information concerning the plans of the CPUSA relating to influence in racial matters, it is requested that authority be granted to place a technical surveillance on the residence of Bayard Rustin or on any future residence to which he moves.

This is a recommendation requesting the Attorney General's authority for installation of a technical surveillance (tesur) on the residence of Bayard Rustin, Apartment 9J, 340 West 28th Street, New York, New York.

### Background

Bayard Rustin, at one time an ardent pacifist, reportedly joined the Young Communist League in 1936. In a speech in 1960 he stated he was a former Communist Party (CP) member. Rustin, who was the Deputy Director of the 8/28/63 March on Washington, has been arrested on several occasions for activities in connection with racial demonstrations. He was secretary to Martin Luther King, Jr., 1956 to 1960 and recent information indicates he may take a position in the Southern Christian Leadership Conference. On 9/20/63 Rustin contacted Benjamin J. Davis, National Secretary, Communist Party, USA (CPUSA), at which time they (Rustin and Davis) mutually agreed to get together for further personal discussions. At a meeting of the National Board, CPUSA, held on 9/25/63, Davis stated that Rustin calls him constantly. Davis recently commented that the Negroes are now willing to know what the CP has to say and will welcome whatever support and leadership communists can give.

### Observations

The increasing importance attached to Communist influence in racial matters necessitates our giving all aspects of this matter preferred attention. Coverage of contacts between Party functionaries and recognized leaders in the current Negro struggle for civil rights is one of the most important goals of our investigations. It is imperative that we penetrate the Party's liaison with Rustin in order to stay on top of this matter. The requested tesur should afford excellent coverage not only of the Party influence on Rustin, but also furnish current information concerning influential leaders in the current Negro struggle who are considered sympathetic and receptive to an approach by the Party. This information is not otherwise available.

Technical coverage of Rustin has the potentiality of greatly assisting the Bureau's efforts in not only determining communist efforts to exploit the racial situation but also to furnish intelligence data as a prerequisite to steps to be taken which would neutralize the Party's endeavors to influence the Negro. There are now 56 investigative technical surveillances in operation plus 7 awaiting installation.

As you are well aware it is our immediate responsibility to not only take every available measure in determining communist efforts to exploit the racial situation and the extent of the Party's influence among the Negro people, but also to take necessary steps to neutralize and frustrate the Party's endeavors. To insure that we are making every effort to meet these responsibilities the Bureau is currently considering the possibility of installing technical-type coverage on the activities of Bayard Rustin.

Rustin, who has admitted past Communist Party affiliation and who was a principal in the 8/28/63 March on Washington, continues to maintain a leadership position in the current Negro struggle for civil rights. The "New York Herald Tribune," in its issue dated 8/14/63, indicated that Rustin was secretary to Martin Luther King, Jr., from 1956 to 1960. As of 11/1/62 Rustin was Assistant Secretary for the Southern Christian Leadership Conference. Recently information has been received indicating Rustin may possibly replace Hunter Pitts O'Dell at the Southern Christian Leadership Conference office in New York. Rustin has recently been in contact with Benjamin Davis, National Secretary of the Communist Party, USA, and on 9/20/63 Rustin and Davis mutually agreed to a future get together for personal discussions. Such information gives every indication that Davis is or will be in a position to influence Rustin.
